All Trials – Will be held in accordance with the current Rules and Regulations of the Kennel Club. Reserves will be approached in a strict order. If a reserve cannot be contacted despite all possible efforts, the next reserve will be offered the run. This decision will stand even if the original reserve appears at the trial. Entry Fees may only be retained under Rule J7.F (1)- (4) and new Covid-19 Rule. Should any stake be abandoned, after all expenses are paid the remaining monies will be divided between the nominees. Those applicants that do not get a run will have their cheques destroyed. The Club reserves the right to refuse entries. Persons who have been refused membership may not enter this society's Trials. No substitution of dogs will be allowed whilst reserves still stand. A statement that should circumstances so dictate the society, in consultation with the judges, may alter arrangements as necessary.

Start Time – All Trials meet at **9.00am** hrs for a **9.30am** prompt start – where reserves will be put in.

Prizes – Certificates & Appropriate trophies. No prize money, Skinners has kindly sponsored all trials.

Trophies must be returned by 1st October 2021 – If you fail to return a Trophy by this date you will be liable to a fine of £50.00. Engraving of trophies is the responsibility of the holder.

Please remember to thank your host, Keeper and guns – we would be lost without them.
