ALL TRIALS Will be held in accordance with the current Rules and Regulations of the Kennel Club. No substitution of dogs whilst reserves still stand. Reserves will be approached in strict order. If a reserve cannot be contacted despite all possible efforts, the next reserve will be offered the run. This decision will stand even if the original reserve appears at the Trial. Withdrawals are subject to KC Rule J6f. Should any stake be abandoned, after all expenses are paid, the remaining monies will be divided between the nominees. Those applicants that do not get a run will have their cheques destroyed. Persons who have ever been refused membership may not enter this Society's Trials
